Explain: **The subject site is 95.957 acres in area. It contains five nonjurisdictional emergent wetlands and one nonjurisdictional palustrine forested wetland that encompass 0.37 acres, in addition to jurisdictional Waters of the US.**

Wetland 1 is a palustrine forested wetland that is 0.05 acres in area. It apparently exists as a result of human-induced disturbance, as it occurs behind a manmade berm. It only receives water from precipitation events which exits through a

discontinuous channel into overland sheet flow. No distinct connections to jurisdictional waters were found via site visit by MVK personnel on 4/6/2022. Therefore, this wetland is considered isolated and non-jurisdictional.

Wetland 2 is an emergent wetland that is 0.08 acres in area. It apparently exists as a result of human-induced disturbance, as it occurs behind a manmade berm. It only receives water from precipitation events which exits the wetland via evapotranspiration and overland sheet flow. No distinct connections to jurisdictional waters were found via site visit by consultants. All of these findings were confirmed by MVK personnel on 4/6/2022. Therefore, this wetland is considered isolated and non-jurisdictional.

Wetland 3 is an emergent wetland that is 0.05 acres in area. It apparently exists as a result of human-induced disturbance, as it occurs behind a manmade berm. It only receives water from precipitation events which exits the wetland via evapotranspiration and overland sheet flow. No distinct connections to jurisdictional waters were found via site visit by consultants. All of these findings were confirmed by MVK personnel on 4/6/2022. Therefore, this wetland is considered isolated and non-jurisdictional.

Wetland 4 is an emergent wetland that is 0.07 acres in area. It apparently exists as a result of human-induced disturbance, as it occurs behind a manmade berm. It only receives water from precipitation events which exits the wetland via evapotranspiration and overland sheet flow. No distinct connections to jurisdictional waters were found via site visit by consultants. All of these findings were confirmed by MVK personnel on 4/6/2022. Therefore, this wetland is considered isolated and non-jurisdictional.

Wetland 5 is an emergent wetland that is 0.12 acres in area. It likely exists as a result of human-induced disturbance. It only receives water from precipitation events which exits the wetland via evapotranspiration and overland sheet flow. No distinct connections to jurisdictional waters were found via site visit by consultants. All of these findings were confirmed by MVK personnel on 4/6/2022. Therefore, this wetland is considered isolated and non-jurisdictional.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

It only receives water from precipitation events which exits the wetland via evapotranspiration and overland sheet flow. No distinct connections to jurisdictional waters were found via site visit by consultants. All of these findings were confirmed by MVK personnel on 4/6/2022.

Therefore, this wetland is considered isolated and non-jurisdictional.
