Explain: **The subject site is 4.25 acres in area. It contains one non-jurisdictional wetland that encompasses 2.93 acres, with no jurisdictional Waters of the US. It is situated between two road beds and likely exists as a direct result of the construction of these roads. Based on previous jurisdictional determinations, the hydrology, soil, and vegetation of similar elevations on the other sides of these roads are unlikely to exhibit wetland conditions. This wetland only receives water from precipitation events which slowly exits the wetland via evapotranspiration and overland sheet**

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

The isolated nature of this wetlands renders it non-jurisdictional, therefore, no permit will be required for activity in these areas.
