SUBJECT: Jurisdictional Determination – Headwaters Incorporated, Project Snowball, Warren County, Mississippi



I refer to your inquiry requesting a jurisdictional determination for the subject property located in Warren County, Mississippi.

Based upon the information provided, it appears there are jurisdictional areas within the property boundary subject to regulation pursuant to Section 404 of the Clean Water Act. In addition, some aquatic resources have been identified as non-jurisdictional. The approximate extent of jurisdictional waters of the United States and non-jurisdictional waters within the boundary of the property described in your letter is depicted on the enclosed map (enclosure 1). Any work involving the discharge of dredged or fill material (land clearing, ditching, filling, leveeing, culvert crossings, etc.) within the identified jurisdictional waters will require a Department of the Army Section 404 permit prior to beginning work. For your information, I have enclosed a copy of our appeals form for the preliminary jurisdictional determination (enclosure 3).


