Reference Invitation for Bids No. DACW38-01-B-0006 for Flood Control, MS River & Tributaries, Channel Improvement, Stone Dike Construction in the Mississippi River at Yucatan, MS-LA, Mile 408.6-R, AHP, and Below Grand Gulf, Mississippi, Mile 400.3-L, AHP, scheduled to open 1400 Hours, 11 Jan 2001, is amended as follows:

Page 26 of 112, Clause 52.219-4, "NOTICE OF PRICE EVALUATION PREFERENCE FOR HUBZONE SMALL BUSINESS CONCERNS." Although subparagraph (b)(3) references FAR Clause 52.219.23, "NOTICE OF PRICE EVALUATION FOR SMALL DISADVANTAGED BUSINESS CONCERNS", it is precluded from use by DOD contracting activities pursuant to FAR Deviation Memo, dated January 25, 2000. No such deviation exists for HUBZone small business concerns as defined by subparagraph (a) of FAR 52.219-4.
