14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.) The following changes and clarifications are made to this request for quotation: 1. Due to a change in requirements, a rotary screw type chiller is no longer an option. As a result, delete "Rotary Screw" from the title of para. 4.1 (page 6). Delete the third sentence of para. 4.1 (page 6) - "Rotary screw chiller shall be constructed and rated in accordance with ARI 550 or ARI 590 as applicable". Delete para. 4.2.5.2 (page 9), Rotary Screw Compressor(s), in its entirety. 2. This award will be made to the lowest bidder that meets the Government's minimum specifications as evidenced by the bidder's data submitted on the system proposed. Contractor's should, therefore, bid that system which meets the Government's minimum requirements at the best price. 3. The existing chiller is a chrysler prototype. It currently contains no refrigerant. It used to contain R-11. 4. Due to current and anticipated EPA requirements and Army requirements, R-22 refrigerant is considered an unacceptable option. 6. Closing time and date for receipt of bids is extended to 12:00 (noon) on 1 February 2001. Notwithstanding this fact, the proposed chiller must still be delivered and completely installed not later than close of business on 30 April 2001.
