Table A17-1. Recreation Resources by Work Item

- Table A17-1 identifies recreation areas with proximity to proposed Work Items.
- When viewing this table, the blue rows indicate a decreased risk of indirect impacts to recreation resources. The orange rows indicate an increased risk of indirect impacts to recreation resources.
- Each recreation area lists a managing agency. The managing agencies are classified as Federal, State, County, City, or private. Out of the 113 unique recreation areas listed, 8.8% are Federally-managed, 21.2% are State-managed, 46.9% are County-managed, 17.2% are City-managed, and 5.3% are privately-managed.
- At least 20.4% of these areas provide 1 or more boat-launch access points, with many providing direct access into the Mississippi River.
- 31.9% of these areas offer consumptive recreation opportunities while 100% offer non-consumptive opportunities. These non-consumptive recreation opportunities include, but are not limited to trails, hiking, camping, wildlife observation, nature photography, boating, environmental education, interpretation, and programmed sports.
- The source of the information below can be found at the websites for each managing agency listed where applicable. An inventory was collected during March 2020 through GIS reference, website reference, and aerial imagery. The inventory is an accurate representation of recreation resources available at the time. Recreation resources near each work item is not limited to this list.
