portion of a Pond #3 with a wetland fringe around to upper end of a man-made stock pond. Both stock pond/wetland not regulated per 1986 Regs (preamble waters). Ponds 1, 2, and 4 are also man-made stock ponds built in uplands and not part of the tributary system not regulated per 1986 Regs (see preamble waters). Drain 17 appears to be a man-made ditch clogged with debris and leaves. It has a small drainage basin and has not evidence of OHWM, even though the topo map shows a blue line, it is mostly sheet flow, there is a small bank in the upper reaches, but it goes away as you do down the slope.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
