C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: This basis form documents a non-tidal drainage ditch excavated on dry land. According to the Final Rule for Regulatory Programs of the Corps of Engineers, 51 Fed. Reg. 41,206, 41,217 (November 13, 1986), this feature is generally not considered waters of the U.S. Furthermore, the on-site ditch is adjacent to a road, was excavated wholly in and

draining only uplands, and does not carry a relatively permanent flow of water; therefore, according to Rapanos Guidance, this ditch is not a water of the U.S.

This ditch is visible on all available aerials dated 1994- 2017, as well as LiDAR. According to the AJD requestor, the ditch was excavated to the adjacent road to intercept sheet flow from the adjacent roadway, and then convey that flow to the west to an unnamed tributary to Spencer Bay via a culver under the adjacent road.

A previous AJD (MVK-2014-783) determined that the upslope, abandoned mine contained no jurisdictional features.

As calculated by the use of LiDAR, this ditch only drains approximately 10-15 acres. Flows are expected to be ephemeral and only in response to rainfall events, as the Magnet soil series is a well-drained soil with medium to rapid runoff.
