Explain: **There is a drainage feature located in the center of the property with non-RPW (ephemeral) flow. The non-RPW comes in at the NE corner of the property and has a bed/bank with a discontinuous OHW. The drain flows west**

until it goes up in elevation by 2 feet then connects to a drainage swale, all going down-gradient. At this point the drain loses its morphological features as a stream (no bed and bank, sinuosity, no active flood plain, no substrate sorting, etc.). The feature continues to flow into a pond at the west property line. Below the pond and off site is a well defined stream channel. In addition there are 2 small upland swales that enter the property from the south line, they appear to be sheet flow only. Based on the field observations, the drain features flow from rainfall events only and the flow is for a short duration. There is a 40-ft drop in elevation within the reach. The feature is approx. 43 miles from a TNW.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
