MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Pre-2015 Regulatory Regime Approved Jurisdictional Determination in Light of *Sackett v. EPA*, 143 S. Ct. 1322 (2023),¹ **MVK-2024-43**

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.² AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.³ For the purposes of this AJD, we have relied on section 10 of the Rivers and Harbors Act of 1899 (RHA),⁴ the Clean Water Act (CWA) implementing regulations published by the Department of the Army in 1986 and amended in 1993 (references 2.a. and 2.b. respectively), the 2008 *Rapanos-Carabell* guidance (reference 2.c.), and other applicable guidance, relevant case law and longstanding practice, (collectively the pre-2015 regulatory regime), and the *Sackett* decision (reference 2.d.) in evaluating jurisdiction.

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. The features addressed in this AJD were evaluated consistent with the definition of “waters of the United States” found in the pre-2015 regulatory regime and consistent with the Supreme Court’s decision in *Sackett*. This AJD did not rely on the 2023 “Revised Definition of ‘Waters of the United States,’” as amended on 8 September 2023 (Amended 2023 Rule) because, as of the date of this decision, the Amended 2023 Rule is not applicable **Mississippi** due to litigation.

1. SUMMARY OF CONCLUSIONS.

3. REVIEW AREA.

- **The review area is comprised of ~58 acres in Yazoo County, Mississippi. (-90.4004240°W 32.6286235°N). There is 1 lake present onsite totaling 42.15 acres, 5 forested wetlands totaling 3.18 acres, 5 ephemerals/non-RPW streams totaling 752.10 linear feet, and 1 perennial RPW stream totaling 185.76 linear feet. The lake was made by damming (Kirk Creek) the perennial stream to be used as a flood water retarding structure.**

4. NEAREST TRADITIONAL NAVIGABLE WATER (TNW), INTERSTATE WATER, OR THE TERRITORIAL SEAS TO WHICH THE AQUATIC RESOURCE IS CONNECTED.

- **The nearest TNW is the Big Black River.**

5. FLOWPATH FROM THE SUBJECT AQUATIC RESOURCES TO A TNW, INTERSTATE WATER, OR THE TERRITORIAL SEAS

- **PFO 1-5 drains directly into Lake 1 since they are abutting the lake. Ephemerals 1-3 drain into Lake 1 as well. Ephemeral 5 flows south via overland sheet flow to Perennial 1 (Kirk Creek). Ephemeral 4 drains south directly into Perennial 1 (Kirk Creek). Lake 1 drains into Kirk Creek via spillway then Kirk Creek flows south for ~3 miles until dumping into the Big Black River. The Big Black River then flows for ~13 miles before converging to the upper limits of Section 10 of the Big Black River at Highway 80 in Bovina, Mississippi.**

- **Ephemeral 1 (50.36'), Ephemeral 2 (51.76'), Ephemeral 3 (154.09'), Ephemeral 4 (132.06'), and Ephemeral 5 (363.82') are ephemeral tributaries/Non-RPW/Non-Jurisdictional which do not meet the relatively permanent standard to be considered jurisdictional, therefore ephemerals 1-5 are non-jurisdictional. Features were verified via site inspection conducted by the consultant.**

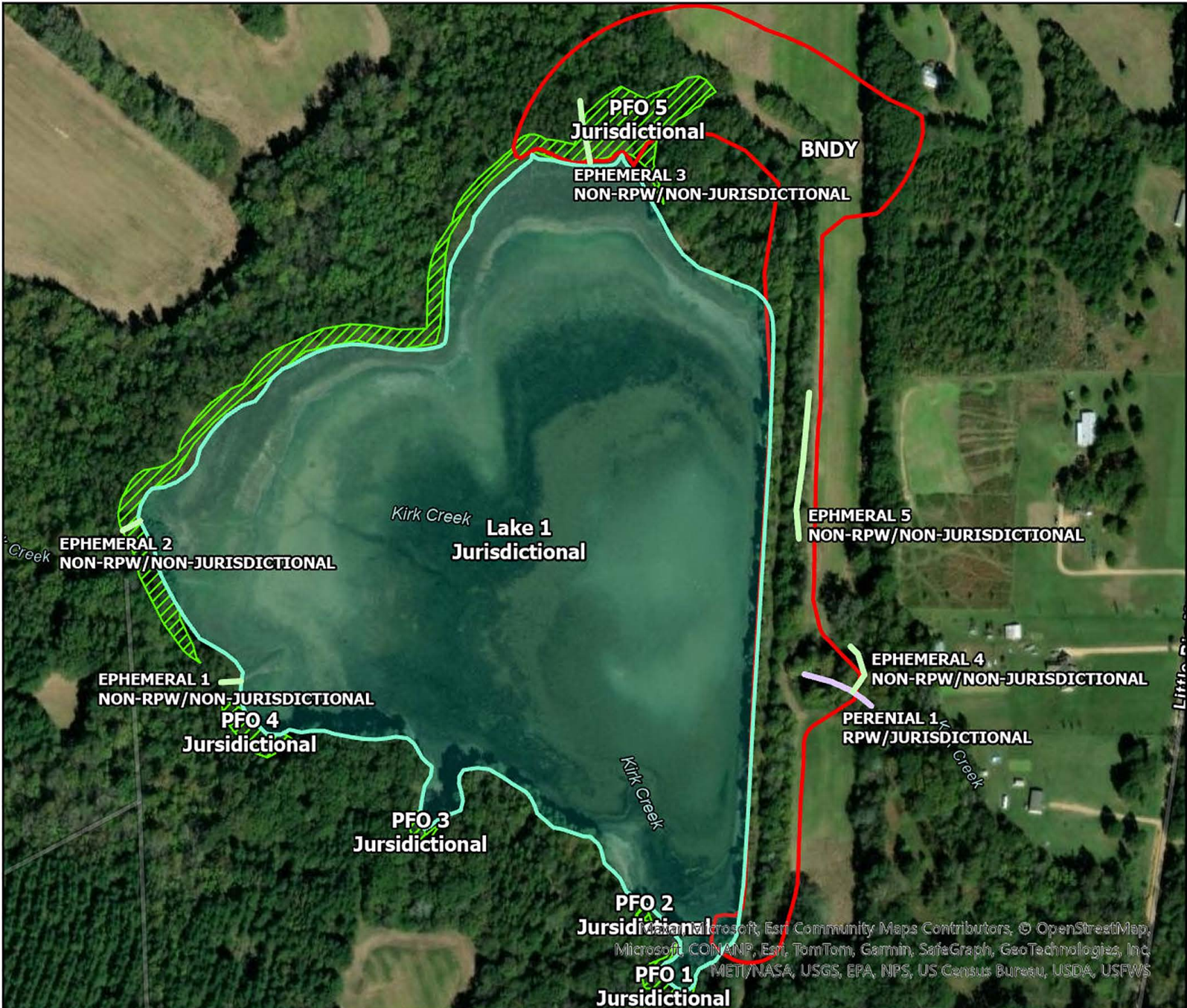

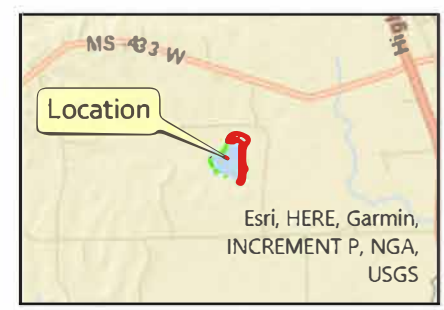
