Corps of Engineers Report (USACE):

- Stacy S. reported the Tompkins Bend Boat Ramp was near completion. This will expand the Boat Ramp parking by approximately 15 parking spaces. Parking blocks were added to show delineation of the parking spaces. Gravel to be laid down and packed in soon.
- Stacy S. reported ongoing work on the Brady Mountain Wastewater installation.
- Stacy S. reported that Eric Jenkins (former Resource Manager at Lake Greeson) was selected as the new Operation Project Manager for Lake Ouachita, DeGray Lake and Lake Greeson.
- Stacy S. reported we have 5 employees deployed to Puerto Rico on Temporary Roofing and Debris Removal Missions.
- Stacy S. reported he met with Windstream on the Denby Bay Bridge clearing and they were not concerned with their line being impacted.

FOLO Update:

- Jerry S.-Financial Report- \$78,869 in Total Assets.
- Grab-A-Bag updates on installation of stickers. Derick W. showed the group the stickers and will be put out next week.
- Robert C. showed group a "bike repair station kit" he wanted to propose to the group to purchase and place along the trail. Locations possibly at Avery, Crystal Springs by church arbor and Denby Bay by ADA trail. These units cost around \$1,500 each.
- Jerry S. noted there is grant money available for these through Montgomery County Health Advisory Board he would be applying for.

LOViT Update:

- LOViT Traildogs had meeting with USFS/USACE at the Womble Office. Strengthened the relationship of activities and ongoing support. No big issues to note.
- Reconstruction date of the ADA Trail. Set meeting for November 16th at 10 AM to meet USACE and Traildogs at the site to discuss tool needs, disposal of wood and how much we want to tackle.
- Trail Maintenance on the LOViT. The arrows signs installation process is ongoing. IMBA has recently worked the entire trail of any downed trees and repairs to surfaces.
- Bike Fixation Station was discussed in the FOLO Update.
