

Potential Replacement Plans: (Several to choose from)

- Jerry opens the floor for discussion:
 - Jerry- curious to whether or not spending treasury money on this would be a good idea- (WAS THERE A MOTION MADE?)
 - Look into using the individual who built the North Woods Trail (Builder: Gerado)
 - T. Butler- possibly use university programs such as; UofA, SAU, UALR, etc.
 - B. Barnes suggests utilizing an accredited team of engineers
 - Need to branch out and gather bids on the project; try to look for packaged deals with everything all in one bid
 - Do it ourselves: Would still need materials supplier and probably Contractor
 - Galvanized Steel
 - o Steel Piping
 - o Aluminum framing (Jerry wanted to research option further)
 - o Concrete
 - Elmer Provided pricing table (expensive)
 - Could possibly negotiate pricing to reduce costs
 - Materials should probably be able to withstand fire
 - Jerry suggests shortening the trail
 - Stacy states possible if it follows the same path of the previous trail which would allow for a categorical exclusion.
 - I suggested using traffic counter #'s to get idea of how many use the trail
